FLIGHT PROGRAMME CHANGES

All prices, dates, times, routes and choice of airlines are subject to alteration or cancellation without prior notice. Please refer to attached itinerary for flight date, departure time and airport terminal and arrival information. All journeys must commence from UK, unless prior arrangements have been made and authorised.

RECONFIRMATION

Airlines require that passengers reconfirm their onward or return journey reservation at the destination with their local office or its representative office at least 72 hours prior to departure. Failure to do so will result in the cancellation of confirmed reservation and incur additional charges. Check-in times vary, please clarify locally.

AIRPORT TAXES

UK departure taxes, passenger service charges and other local taxes are included.

MODE OF PAYMENT

PASSPORT INFORMATION
